

What happened last week?

- Minister of Justice Abdülhamit Gül resigned; Bekir Bozdağ, who had held the same position twice before, was appointed to replace him. It was <u>claimed</u> that the presentation of the footage of Istanbul Metropolitan Municipality Mayor Ekrem Imamoğlu as he was "followed through CCTV cameras" was the last step that led Gül to resign.
- A child, who was put on the stage by President Erdoğan at the mass opening ceremony in Trabzon, targeted Republican People's Party (CHP) Leader Kemal Kılıçdaroğlu and addressed him as "Mr. Kemal". Erdoğan and the ministers accompanying him laughed at the speech of the boy, who called Kılıçdaroğlu a "traitor". A "vote was demanded" by a boy whose father has been in prison for 10 years and was asking Erdoğan for his father's release...
- In the circular signed by President Erdoğan, <u>it was stated</u> that "necessary steps will be taken" against TV shows with "especially foreign content", which are defined as "open and covert activities" aimed at wearing down "our national and moral values", "our family and social structure". Objections from non-governmental and media professional organizations arose against the circular, which was adorned with vague and undemocratic expressions.
- Politician Aysel Tuğluk has difficulty in expressing herself and was unable to defend herself, and was asked to be excluded from the Kobane Case because of this but the request was denied. Tuğluk will be kept under observation at the Forensic Medicine Institute for 15 days.
- The Committee of Ministers of the Council of Europe initiated a sanction process due to the non-implementation of the European Court of Human Rights decree regarding the Osman Kavala case. It was decided that the file should be evaluated by the European Court of Human Rights. Thus, Turkey went down in history as the second country, after Azerbaijan, against whom a violation process was initiated. Erdoğan criticized the Committee of Ministers' initiation of the infringement process by repeating his past words: "What the ECtHR said, what the Council of Europe said, we don't care much. We do not recognize those who do not recognize our courts. I say this very clearly..."
- The European Court of Human Rights ruled on a violation regarding the lifting of immunity of 40 Parliament members from the Peoples' Democratic Party (HDP) in 2016, including former Peoples' Democratic Party (HDP) Co-Chair Selahattin Demirtaş. The court ruled that the immunity of the Parliament members was lifted in violation of the Constitution and that their freedom of expression was violated.
- The number of daily cases in the pandemic exceeded 100 thousand and the number of daily deaths exceeded 200. Meanwhile, the Minister of Health said, "There is no need

to worry." The scientific world and professional health organizations do not agree. "We are dying because of the policies of the Ministry of Health, which does not take any precautions and leaves the pandemic to itself, and does not care about public health," the organisations stated.

- As the economic outlook in Turkey worsens day by day, thousands of employees, especially those working in courier services, who work for low wages, started to make their voices heard with strikes and protests for humane wage increases.
- The dead bodies of 19 of the 22 refugees, whose shoes and winter clothes were confiscated while trying to cross the Greek border, were found on the Turkish side. The United Nations High Commissioner for Refugees has called for an urgent investigation.
- Naci Inci, the trustee rector of Boğaziçi University, appointed himself to replace the dean of the Faculty of Arts and Sciences he had dismissed. Gürkan Kumbaroğlu was appointed instead of the dean of the Faculty of Economics and Administrative Sciences, who was dismissed, and Fazıl Önder Sönmez was appointed to replace the dean of the Faculty of Education, who was dismissed. Thus, while the trustee staff were appointed to the three faculties, where the elected deans were dismissed, in Boğaziçi University, practically 4 people are managing the 10-member committee at the university, which consists of the rectorate and deans.

Police raid against IHD Diyarbakır Branch

The police raided the building of the Diyarbakır Branch of the Human Rights Association. In the statement made by the association, it was announced that Ferhat Berkpinar, a member of the Board of Directors of the Human Rights Association Diyarbakır Branch, whose house was raided at the same time, was detained. During the raids carried out within the scope of an investigation carried out by the Adiyaman Chief Public Prosecutor's Office, the activities of the association and the personal documents of its members were seized. A confidentiality order was issued on the investigation file, and the requests of the lawyers to meet with Berkpinar, who was under custody, were also rejected on the grounds that there was a meeting ban for the detainee.



DBP Diyarbakır Provincial Co-Chair arrested

Democratic Regions Party (DBP) Provincial Co-Chair Seval Gülmez was arrested within the scope of the investigation launched by Diyarbakır Chief Public Prosecutor's Office with the allegation of "making propaganda for a terrorist organization" after images taken at an event held at the Democratic Regions Party (DBP) Diyarbakır Provincial Building were shared on social media. Gülmez was accused of the protests

and events she participated in, the interviews she gave at events and the books she had in her home, and was previously detained with a police operation in April 2021, being arrested on charges of "terrorist organization membership". In the first hearing held 5 months after her arrest, she was released.



Turkey becomes 2nd country requesting censorship most against journalists on Twitter

According to the data shared by Twitter; in 2021, 5 thousand 454 separate content removal requests were made about 6 thousand 825 accounts from Turkey, and as a result of these requests, 203 tweets and 27 Twitter accounts were blocked. Turkey ranks 4th in both the rankings of the countries with the most content removal

"requests" and the countries with the "most content removals". On the other hand, it took the 2nd place by making a big difference to two counties closest to Turkey with 108 separate requests for journalists and news sources approved by Twitter.

Lawsuit against journalist Sultan Eylem Keleş

Journalist Sultan Eylem Keleş, who was prevented and detained by the police while following a protest held in Istanbul in 2020, was prosecuted on charges of "resisting to prevent duty" and "insult". The first hearing of the case will be held on September 13 at the Istanbul 56th Criminal Court of First Instance.

Another investigation against Şenyaşar family



A new investigation has been launched against Emine Şenyaşar and her son Ferit Şenyaşar, who have been on guard duty in the Urfa courthouse for months, after Emine Şenyaşar's husband and two sons were murdered by the bodyguards and relatives of Justice and Development Party (AKP) Parliament Member İbrahim Halil Yıldız in 2018. During the justice watch that lasted for

more than 330 days, mother Şenyaşar testified 13 times and son Ferit Şenyaşar 4 times.



Protest bans

The protest ban implemented in Van since 2016 is maintained by the Governorate. The Van Governorate declared a new "protest ban" on the "providing pretext of national security". Governorates in Siirt, Mardin and Hakkari declared continuation of protest and а demonstration bans for another 15 days, citing the protection of "public order", "national security" and protections against the Coronavirus

outbreak.



Conscientious objectors convicted

Conscientious objector Şendoğan Yazıcı, who was prosecuted on charges of violating the Military Criminal Code, was sentenced to 1 month and 20 days in prison by the Borçka Criminal Court of First Instance. In the meantime, conscientious objector Reha Eskidir, who was prosecuted at the Zonguldak 3rd Criminal Court of First Instance on charges of violating the Military Criminal Code, was

sentenced to 5 months and 18 days in prison. In addition, a new lawsuit was filed against Eskidir with the same accusation.



7 Şerzan Kurt Free Youth Association members convicted

Muğla 2nd Assize Court sentenced 7 people in the lawsuit filed against 9 members of Şerzan Kurt Özgür Youth Association on charges of "terrorist organization membership" and "making propaganda for a terrorist organization". Considering press statements and other activities of associations as "illegal organizational activities", the court sentenced 7 people to 9 years and 3 months in prison.

Investigation against journalist Sevda Karaca

Following the complaint of Lieutenant General Musa Çitil, who was tried and acquitted for 13 unsolved murders in Derik district of Mardin, an investigation was launched against Evrensel Daily columnist Sevda Karaca on the charge of "targeting those taking part in the fight against terrorism," "insulting a public official" and "making propaganda for a terrorist organization"

Social media investigation against journalist

An investigation was launched against Özgür Boğatekin, the News Director of the Fırat Gerger Daily, following an anonymous denouncement against him based on his social media posts and the news about the bad experiences he had with the recent heavy snowfall. Within the scope of the investigation, the journalist is charged with

"making propaganda for a terrorist organisation." 8 investigations have been launched against the journalist in the last year.



Journalists' appeal denied after conviction over news on MIT

Journalists Aydın Keser, Ferhat Çelik, Murat Ağırel, Barış Pehlivan and Hülya Kılınç were sentenced to prison on charges of "disclosure of information and documents related to intelligence activities" due to the news about a Turkish National Intelligence Agency member who died in Libya. The journalists' appeal against their

sentence was denied by the 4rd Criminal Chamber of Istanbul Regional Court.



Investigation against journalist Nişmiye Güler

Jinnews reporter Nişmiye Güler was detained from her home in Istanbul as part of an investigation launched by the Diyarbakır Bismil Chief Public Prosecutor's Office. The journalist was accused of "terrorist organization membership" and "making propaganda for a terrorist organization" within the scope of the investigation, and was released on the condition of judicial measures after testifying at the courthouse.



Criminal complaint against acquitted journalist

Journalist Buse Söğütlü was acquitted in the lawsuit filed against her on charges of "targeting those taking part in the fight against terrorism" for a tweet criticizing judge Akın Gürlek. The Istanbul 23rd Assize Court decided to file a criminal complaint against the journalist on the charge of "insulting a public official".



Refugee to be deported over participating in protest

The appeal of Iranian refugee Esmail Fattahi, who was ordered to be deported for participating in the protest against the annulment of the Istanbul Convention, was denied by the Denizli 1st Administrative Court, who claimed that he posed a threat to "public order and public

security".
