### July 2022 Report

# **General Evaluation:**Osman İşçi (Human Rights Association - IHD Headquarters)

Recurring issues continued in July, such as police intervention against almost all peaceful demonstrations, bans, trials, and access to websites.

The attacks against Alevi Cemevis, the events that Furkan Foundation members and managers wanted to organize, or the events that LGBTQI+s wanted to organize as part of Pride Week reveal that; the fact that the right to assembly and demonstration, and the freedom of expression itself, are not seen as rights, that there are restrictive measures in the law, that these restrictive measures are applied more restrictively by the execution and an effective investigation is not carried out against the violations in short, impunity - affect everyone who uses these rights, from different religious identities, different sexual orientations, and different sexual identities.

Another issue is the investigation launched right after the General Assembly held by the Peoples' Democratic Party (HDP) in July, the detainment of some people who attended the General Assembly, the subsequent request for the lifting of immunity of Democratic Regions Party (DBP) MP Saliha Aydeniz, prosecutions of Peoples' Democratic Party (HDP) members, including former Co-Chairs Selahattin Demirtaş and Figen Yüksekdağ, MPs and mayos. All these reveal how limited the right to association is, and specific to a political party, how limited participation in political life is. This is the result of the ongoing armed conflict in Turkey, and approaches to the Kurdish Question with violence-oriented or violence-based policies and tools.

As human rights defenders, we insist that the solution to this problem must be through peaceful means, that the Kurdish Question or the problems of other ethnic identities and religious belief identities should be resolved through peaceful means. What needs to be done for this is a right-based amendment of the Constitution and related laws, their implementation, an effective investigation of those responsible for violations, and the abandonment of policies of impunity.

Naturally, these pressures are directed not only to the Peoples' Democratic Party (HDP) members, but also to news agencies that follow the violations and journalists who write about these issues. The arrest of 16 Kurdish journalists and reporters covering this issue during this period, and then the detainment of journalists who protested their arrest in Ankara, are just two of the concrete examples of the current spiral of violence and how one right violation leads to another.

20: Izmir After the press statement in front of the Alsancak Türkan Saylan Cultural Center on the anniversary of the Suruç massacre, the police intervened against the crowd who wanted to march to Gündoğdu Square to throw carnations in the sea with tear gas and rubber bullets, detaining 20 people.

In the police intervention against the march organized within the Kemal Kurkut Football Tournament in Istanbul, regarding the incident in which 9 civilians, including children, were killed and 23 people were injured, as a result of the artillery fire allegedly carried out by the Turkish Armed Forces against the rural area of Zakho city within the borders of the Iranian Kurdish Regional Government; 11 people were detained. The police did not allow the People's Democratic Party (HDP) Youth Assembly members, who wanted to play a soccer match in the city to protest the detainments. Afterwards, the police intervened in the group, which

opened a banner that read, "Detainments and pressures cannot intimidate the youth," and detained 7 people.

party administrators.

detained on charges of "making propaganda for a terrorist organization".

#### 2. Investigations and Prosecutions

O1: Istanbul In the final hearing of the lawsuit filed at the 7th Criminal Court of First Instance, in which Berat and Serhat Albayrak demanded 200,000 TL in compensation from journalist Barış Terkoğlu due to an interview in the newspaper, the court denied

the claim for compensation.

04: Ankara

The second hearing of the lawsuit filed against 8 managers of the Health and Social Service Workers Union (SES) was held at the 22nd Assize Court. It was requested that the defendants be penalised for the crimes of "terrorist organization membership" and "making propaganda for a terrorist organization" on the grounds of their union activities. After the defense statements, the court decided for the arrest of Gönül Erden's to continue, and ruled for the arrest of SES Co-Chair Selma Atabey, adjourning the hearing to October 3, 2022.

4 people, including Peoples' Democratic Party (HDP) Youth Assembly members, were detained during the house raids carried out in the investigation launched on the grounds of the slogans chanted at the Peoples' Democratic Party (HDP) 5th Ordinary Great Congress.

04: Istanbul

A lawsuit was filed against 52 Boğaziçi University students at the 4th Criminal Court of First Instance for violating the Law on Meetings and Demonstrations.

04: Istanbul

Journalist Ali Ergin Demirhan was acquitted in the judgment hearing of the lawsuit filed against him at the 55th Court of First Instance due to his social media posts.

04: Izmir

One person was detained and was taken to Ankara on the grounds that they were making propaganda for a terrorist organization after the Peoples' Democratic Party (HDP) General Congress.

04: Urfa

Within the scope of the investigation launched on the grounds of the slogans chanted at the Peoples' Democratic Party (HDP) 5th Ordinary Great Congress, Peoples' Democratic Party (HDP) provincial director Ömer Altın was detained at the city entrance after returning from the congress.

05: Diyarbakır

The lawsuit filed against Democratic Regions Party (DBP) Assembly member Selahattin Aslan at the 4th Assize Court was adjourned to September 29, 2022.

05: Diyarbakır

The lawsuit filed against journalist Nurcan Yalçın at the 4th Assize Court on the grounds of her interviews with women before the curfews in Sur district between 2015-2016 was adjourned to September 22, 2022.

05: Diyarbakır

The lawsuit filed against Sur Municipality Co-Mayor Filiz Buluttekin, who was previously replaced by a trustee, at the 4th Assize Court has been adjourned to September 29, 2022.

06: Diyarbakır

The lawsuit filed against Sırrı Süreyya Önder at the 4th Criminal Court of First Instance with the allegation that he committed a crime in accordance with Article 301 of the Turkish Criminal Code in his expressions during a testimony under detainment, was adjourned to September 21, 2022.

06: Istanbul

At the final hearing of the lawsuit filed against journalist Can Ataklı at the 22nd Criminal Court of First Instance, Ataklı was sentenced to a judicial fine of 10,110 TL due to his remarks in a TV show he participated in.

06: Manisa

The 4th hearing of the lawsuit filed against the Turgutlu District Co-Chairs of the Peoples' Democratic Party (HDP) was held at the 3rd Assize Court on the charge of "terrorist organization membership".

08: Ankara

The latest hearing of the case filed against 108 Peoples' Democratic Party (HDP) members and executives, 21 of whom are arrested including the former co-chairs, was held at the 22nd Assize Court (between June 27 and July 08, 2022).

It was claimed that Mehmet Yılmaz committed suicide. 25: Van It was learned that 4 prisoners held in the High Security Prison, whose COVID-19 tests were positive, were not transferred to the hospital despite their requests. 26: Diyarbakır With a decree issued by the 4th Criminal Judicature of Peace, the website of Etkin News Agency was blocked on the grounds of protecting national security and public safety. 26: Diyarbakır Three people visiting the Church of the Virgin Mary in Sur district were threatened by a group outside the church, saying "Don't go to the church, or we will kill you". 26: Van It has been learned that 6 prisoners have been kept in solitary cells for 67 months

in the High Security Prison. In addition, it was stated that the social and cultural rights of the prisoners were restricted and the petitions written by the prisoners to be sent to the Prosecutor's office and the Ministry of Justice were confiscated by the prison administration.

26: Van It has been learned that the dental treatments of the prisoners in the High Security Prison are not carried out regularly.

The Anatolian 3rd Criminal Judicature of Peace has blocked access to the 28: Istanbul websites of Evrensel, T24 and Expression.org on the grounds that many news stories and social media posts about Mustafa Doğan İnal, the former lawyer of the President of the Republic, "violated his personal rights".

30: Ankara Attacks were made against the Şah-ı Merdan Cemevi, Turkmen Alevi Bektashi Association, Tuzluçayır Democratic Alevi Association, Ana Fatma Cemevi, Gökçebel Village Association, and Batıkent Serçeşme Cemevi.
