# What happened last week?

- Three days later, President Erdoğan issued another presidential decree canceling the expropriation of 190 parcels of agricultural land in İkizköy, Çamköy and Karacahisar around Akbelen Forest for use as a lignite mine site, which he had signed on March 12.
- The European Court of Human Rights announced its decision in the case of <u>Kanatlı</u> <u>vs. Turkey</u>: The Court ruled that the lack of a public service option in return for compulsory military service was a violation of Article 9 of the Convention.
- The microphone was taken away from a young man who wanted to ask a question about the "Gaza-Israel war" to AKP Istanbul Metropolitan Municipality mayoral candidate Murat Kurum, who participated in a panel discussion on HaberTürk channel. The host of the program, Mehmet Akif Ersoy, made a statement in response to the reactions, citing that "the question was not in accordance with the format of the program explained to the participants".
- Armenian academic Ani Sarukhanyan, who has been working at Ankara University's Caucasian Languages and Cultures Department for five years, announced that the university administration did not extend her contract without any justification. Sarukhanyan <u>released a video</u> expressing the discrimination she has suffered...

## 9 thousand lira fine for police brutality

Following the Constitutional Court's violation decision on the police violence against Beyza Kural, former reporter of Bianet news website, the verdict was announced in the lawsuit filed against three police officers for "violation of freedom of work and labor". The court sentenced the police officers to a judicial fine of 9

thousand Turkish Liras and deferred the announcement of the verdict. The court filed a criminal complaint against the accused police officers for assault and preventing the exercise of freedom of thought.



#### **Detained for street interview**

Mehmet Şah Karataş, a citizen who spoke during a street interview conducted by the YouTube channel Kendine Muhababir on the upcoming local elections in Güngören, Istanbul, was detained immediately after the interview on charges of "inciting the public to hatred and hostility". Karataş stated that he was beaten in the police car

and that 20 thousand TL he was carrying was confiscated by the police officers; he filed a criminal complaint.



# TRIALS OF FREEDOM OF EXPRESSION

#### **Mehmet Salih Turan Case**

Retrial of the case against journalist Mehmet Salih Turan due to "making propaganda for a terrorist organization" through his social media posts, which was reversed by the Constitutional Court on the grounds that his rights were violated.

**Court:** Istanbul 32nd Assize Court **Hearing outcome:** The trial will continue on April 24.

#### Abdurrahman Gök Case

The lawsuit filed against Mezopotamya Agency editor Abdurrahman Gök, who was charged with "illegal organization membership" and "propaganda" based on his phone calls with news sources, social media posts and news reports...

Court: Diyarbakır 5th High Criminal Court Hearing outcome: The court decided to continue Gök's travel ban and set the next hearing for June 11.

## Haydar Ergül Case

The lawsuit filed against Democratic Modernity magazine editor Haydar Ergül and 18 Kurdish politicians due to "membership in a terrorist organization"...

**Court:** Istanbul 22nd High Criminal Court **Hearing outcome:** The trial will continue on June 13.

#### Rozerin Gültekin and Ergin Cağlar Case

The lawsuit filed against Jinnews reporter Rozerin Gültekin and Mezopotamya Agency reporter Ergin Çağlar, who were detained during the Gemlik March to protest the visit ban on Abdullah Öcalan.
